# Improving Patient Bedside Handoff Virtual Safe Table

April 22, 2025 - 1:00 - 3:00 pm

Experts in patient bedside handoff emphasize its importance in improving patient safety, communication, and overall care quality by ensuring a smooth transition of care between healthcare providers. The Joint Commission, for example, advocates for including patients and families in handoffs whenever appropriate, as it fosters greater understanding and can lead to better outcomes.

#### Key Aspects and Considerations:

Patient-Centered Approach: Bedside handoffs, when done effectively, can empower patients by involving them in the process, allowing them to clarify information, ask questions, and feel more in control of their care.

Improved Communication and Safety: Bedside handoffs can reduce errors and miscommunication by providing a direct and immediate opportunity for information transfer, clarification, and confirmation, particularly during shift changes.

#### **Meeting Objectives:**

- Discuss a Patient-Centered
   Approach to Bedside handoffs and methods to empower patients by involving them in the process, allowing them to clarify information, ask questions, and feel more in control of their care.
