Dear Friend:

Survivors of rape, molestation and other forms of sexual assault rely on you as a medical provider to treat their physical wounds, provide them with justice and help them endure severe emotional trauma while beginning the difficult recovery process.

Sexual Assault Nurse Examiners are crucial in ensuring that sexual assault patients receive more compassionate care. Specially-trained nurses can reduce re-traumatization of patients and improve the quality of forensic evidence collection, which may increase prosecution rates of offenders. No matter what role you play in this critical process, your invaluable work places you on the frontline in the fight against sex crimes and makes you one of the most important people in victims' lives.

I would like to invite you to attend the **Pediatric/Adolescent Sexual Assault Nurse Examiner (SANE) Didactic Training** on May 12-15, 2026, from 8:00 a.m. – 5:30 p.m. at the Jesse White State of Illinois Building in Chicago. Instructions regarding the pre-coursework will be released on April 9, 2026, and students must complete the pre-coursework by Thursday, May 7, 2026.

The **Pediatric/Adolescent Sexual Assault Nurse Examiner Training** is an important 40-hour training designed to improve our response to sexual assault patients in Illinois. The training is comprised of a combination of pre-coursework and live training in Chicago. Participants can complete the pre-coursework at their convenience; however, the assignments must be completed prior to the due date provided.

This training is for registered nurses, advanced practice providers and physicians who will be providing medical forensic services to sexual assault patients under the age of 18 in an Emergency Room or Approved Pediatric Health Care Facility. Applicants must have a license in good standing, acknowledge the requirements of the training including submitting a current resume, complete the pre-coursework prior to the date listed above, have an established mentor (must be a Child Abuse Pediatrician, PA SAFE, or SANE-P) who has received specialized training in the care of both acute and non-acute sexual assault patients and is performing those exams on a routine basis using the ISP SAECK, work in a pediatric treatment facility's emergency department or have developed a clinical plan with an emergency department and be available for the in-person training. Individuals who have previously completed didactic training are invited to re-attend as space allows.

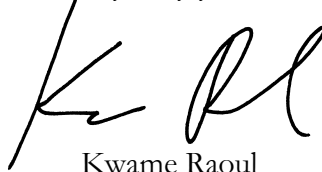
